Natural Gas Tankless Water Heaters

- Natural Gas Small Instantaneous Water Heaters (less than 200 kBtuh, less than 2 Gallon, Low-Medium-High-Draw): >0.81 UEF and >0.87 UEF
- Natural Gas Medium Instantaneous Water Heaters (>76 kBtuh, <200 kBtuh, less than 2 Gallon): >0.90 TE
- Natural Gas Large Instantaneous Water Heaters (>200 kBtuh, less than 2 Gallon): >0.80 TE, >0.90 TE and >0.96 TE

DHW Pump Demand Controls

- DHW Pump Demand Control, Gas MF, 5-50 Units
- DHW Pump Demand Control, Gas Com, 25-250+ Units

Recirculation Pump Timers

- Recirculation Pump Timer, ≤1/12 Hp
- Recirculation Pump Timer, >1/12 and ≤1/3 Hp
- Recirculation Pump Timer, >1/3 Hp
